

COUNCIL REPORT Meeting 15 May 2024



Item 1: Meetings Attended

- Mayor and Councillors attended the Council meeting held on 24 April 2024 in Hope Vale.
- CEO attended (via Teams) the BOM Northern Queensland Weekly Situational Briefing on 29 April 2024
- Mayor and CEO met with QPS Inspector Garry Hunter and Sgt Karl Ford on 29 April 2024 in Hope Vale.
- CEO and Director of Finance and Corporate Services attended (via Teams) a meeting with Jane Frank, Director, Regional Digital Business, Queensland Government Customer and Digital Group for discussion on the establishment of Hope Vale Digital Service Centre.
- Mayor, CEO, and Director of Finance and Corporate Services met (via Teams) with Esther Chew and Cassandra Buddingh from Peddle Thorp and Ricardo Sandoval Lillo from DATSIP on 2 May 2024, for discussions on the Hope Vale Town Precinct Options.

Item 2: Remote Jobs and Economic Development Program (RJED).

The National Indigenous Australians Agency (NIAA) wish to liaise with Council on the design of the new Remote Jobs and Economic Development Program (RJED). The RJED will start in the second half of 2024 and create 3000 jobs over three years in remote areas of Australia.

The Australian Government has committed to replacing the Community Development Program (CDP) with a program that will:

- create local, paid jobs with good conditions
- let communities decide what jobs are created
- be developed in partnership with First Nations people.

A Factsheet on the Remote Jobs and Economic Development Program (RJED) is attached to this report (Attachment A)

Item 3: Far North Queensland Regional Organisation of Councils

Item 6: Hope Vale Educational Precinct

The Infrastructure Strategy, Infrastructure Services Division, of the Department of Education has forwarded to Council its Draft Site Analysis for the Hope Vale Campus of the Cape York Aboriginal Academy. (Attachment D)

In discussions with Departmental Officers, it was suggested that Council should submit the plans for the redevelopment of the building behind the existing Kindy building to the Department for funding. The redevelopment of the newer building will enable it to be used as the Kindy premises. (Attachment E)

Recommendation:

- (a) Draft Site Analysis for the Hope Vale Campus of the Cape York Aboriginal Academy, and
- (b) Make application to the Department of Education for funding for the redevelopment of the proposed Kindy building.
